5TM Ltd is a properly registered Ministry/Charity for the purposes of giving much needed aid to children in foreign countries. Currently there are 100's of children (like the photo of Shaheena above who made this magnificent transformation over a period of 4 months) who are desperately in need of help in many ways:

Medical, food, water and shelter are the main problems and priorities. These children have either been dumped or sold by their parents who simply cannot afford to keep or feed them. They have no home; often they are in danger of having to become local prostitutes. This project is in conjunction with both the Good Shepherd Home and YWAM's House of Hope projects. These children suffer from many medical conditions including HIV/AIDS, malaria, and water borne diseases, STD's.

There is a need to have a medical treatment and food & shelter for recuperation. One of the major problems is not having an adequate water supply and suitable waste disposal. We are hopeful we can raise through our "coins of life" campaign about \$10000 for on going relief per annum. A full time program has been initially costed at approximately \$10000 per annum in full relief however an initial \$10000 is needed urgently to build the very basics of infrastructure and supply medical needs.

You can get a tax discount/rebate by helping these dedicated people through this registered ministry. But more directly the money you give will go exactly to that cause and give you back money in your pocket to give to other matters as you feel to do so. This is truly a blessing to be able to do up to 50% more again with the same amount of financial help.
